

NOTICE OF INVITATION FOR BID

Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #25-666, Crystal Lake Park Boardwalk.**

A **MANDATORY** pre-bid will be held on Wednesday, September 17, 2025, at 9:00 a.m. in the Procurement Conference Room 150 in the Polk County Administration Building located at 330 W. Church St, Bartow, FL 33830. A **MANDATORY** site visit will immediately follow at Crystal Lake Park, located at 2500 North Crystal Lake Drive, Lakeland, FL 33801. An authorized representative or agent of the Bidder must be present at this meeting, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive.

Respondents must submit one (1) original copy of the bid submittal prior to 2:00 p.m. on the bid receiving date. Bids must be submitted in a "sealed" parcel or electronically through Polk County's secure website, Kiteworks. Bids will be publicly opened at 2:00 p.m. on receiving date.

Scope of Work: Provide all labor, material, permitting, and supervision to demolish the existing boardwalk located on Crystal Lake and construct the new boardwalk in accordance with project specifications and drawings outlined in this bid document.

The construction cost estimate for the project is \$995,843.00.

Qualification Requirements: Hold a valid State of Florida Certified Building Contractor (CBC), General Contractor (GC), or a Marine Contractor (SCC) license and shall have performed three (3) projects of similar size and scope services as the prime contractor within the past three (3) years.

Liquidated Damages will be assessed at \$200.00 per day.

The contract time for this project is a total of 120 calendar days from Notice to Proceed to reach Substantial Completion and an additional 30 days from Substantial Completion to Final Completion.
