Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #25-667, Poinciana Park Artificial Turf Fields.**

A **MANDATORY** pre-bid and site visit will be held Tuesday, September 16, 2025, 3:00 p.m. in the pavilion located near the park entrance at 5109 Allegheny Road, Haines City, FL 34759. An authorized representative or agent of the Bidder must be present at this meeting and site visit, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive. Scope of Work: Provide all labor, material, permitting, and supervision for the construction of (3) three artificial turf soccer fields including a cricket pitch, and civil site work in accordance with project specifications and drawings outlined in this bid package.

The construction cost estimate for the project is \$4,236,363.00.

Qualification Requirements: Current State of Florida Certified Building Contractor (CBC) or General Contractor (GC) license and shall have performed three (3) projects of similar size and scope services as the prime contractor within the past three (3) years.

Liquidated Damages will be assessed at \$200.00 per day.

The contract time for this project is a total of 210 calendar days from Notice to Proceed to reach Substantial Completion and an additional 30 days from Substantial Completion to Final Completion.
