

NOTICE OF INVITATION FOR BID

Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID 26-218, CR 540 CYPRESS GARDENS ROAD AT LAKE NED ROAD INTERSECTION IMPROVEMENTS.**

Bids must be submitted in a "sealed" parcel or may be submitted electronically. Bids will be publicly opened and read at 2:00 p.m. on receiving date.

Scope of Work: Construct a roundabout on the intersection of Cypress Gardens Rd and Lake Ned Rd which is located in Winter Haven, Florida. The construction cost estimate for the project is \$1,535,044.10. The number of days to complete the project are 210 days.

Qualification Requirements: The prime contractor shall be a certified general contractor in the State of Florida. Prime contractor must have been in business under the same name or EIN number for a minimum of 5 years. The contractor should submit with their bid a minimum of three (3) recent references of comparable work for public agencies such as cities, counties, FDOT that were completed within the last ten (10) years by the prime contractor. Percentage of Work: The prime contractor shall perform a minimum of 40%.
