Description: Furnish all labor, materials, supervision, and equipment necessary to mill, overlay, stripe, demo and concrete the Sheriff-Fleet Eaton Park parking lot located at 2815 Winter Lake Road, Lakeland, FL 33803. A Public Construction Bond for 100% of the contract is required. The contract time for this project is a total of 45 calendar days from Notice to Proceed for final completion. The construction cost estimate for the project is \$214,200.00.

Qualification Requirements: Contractor shall have experience in completing similar projects within the past five (5) years.
